

### WHY BECOME A VOLUNTEER?

- To provide an invaluable source of support, resources, information, and guidance to victims of crime and their children.
- To better understand the dynamics of intimate partner violence.
- To act as a critical resource to RPD detectives and officers in assisting victims.
- To gain knowledge of the RPD operations, and the criminal and civil justice systems.
- To touch the lives of your neighbors in crisis, while at the same time growing and learning as individuals.

### WHO ARE WE?

The Victim Services Unit provides services to victims and survivors of all ages, and backgrounds, which have been touched by homicide, sexual violence, domestic violence, stalking, robbery, elder abuse, child abuse, drunk/drug driving, economic exploitation, hate crimes and other devastating crimes. The Volunteer Victim Advocate Program was developed to respond to the high volume of Intimate Partner Violence Cases. Volunteers work specifically with this crime category.

### **QUALIFICATIONS**

- 18 years of age or older
- Good moral character
- No felony convictions
- Current U.S. citizen or possess a permanent resident card or an alien registration receipt card
- Pass a police background check and criminal history
- Have a valid Nevada Driver's License

Because volunteers will be working in a police department, reference checks and a criminal history background check will be conducted.

### REQUIREMENTS

- Complete a 45-hr. training course
- Shadow a staff advocate and work on cases a minimum of (12) hours
- Complete a 7-hr. police ride along
- Make a one-year commitment
- Volunteer a minimum of 10 hrs. per month
- Attend 8 hrs., ongoing in-service training annually
