- b. Are you under indictment or information in any court for a **felony**, or any other crime, for which the judge could imprison you for more than one year?
- c. Have you been convicted in any court of a **felony**, or any other crime, for which the judge could have imprisoned you for more than one year, even if you received a shorter sentence including probation?
- d. Are you a fugitive from justice?
- e. Do you have any outstanding warrants for your arrest?
- f. Are you an unlawful user of, or addicted to, any depressant, stimulant, or narcotic drug, or any other controlled substance including prescription medications (other than marijuana)?
- g. Are you a lawful medical user of marijuana or any of its derivatives under the laws of the State of Nevada or any other state? If so, please provide your medical marijuana card information below.
- h. Are you a lawful recreational user of marijuana or any of its derivatives under the laws of the State of Nevada or any other state?
- i. Have you ever been adjudicated mentally defective (which includes having been adjudicated incompetent to manage your own affairs) or have you ever been committed to a mental institution?
- j. Have you been discharged from the Armed Forces under **dishonorable** conditions?
- k. Are you subject to a court order restraining you from harassing, stalking, or threatening your child or an intimate partner or child of such partner?
- l. Have you been convicted in any court of a misdemeanor crime of domestic violence? This includes but is not limited to domestic battery, stalking, or simple battery against an intimate partner.
- m. Have you ever renounced your United States citizenship?
- n. Are you an alien **illegally** in the United States?
